Re: Open Enrollment for Medical/Dental/Vision/ FSA Coverage effective May 1, 2023

We are very pleased to share that we have renewed our employee health insurance for the next plan year with no changes for another year. We will remain with *Empire Blue Cross Blue Shield* for our medical plan and *Cigna* for our dental plan with *no changes in benefits or employee contributions*.

Benefit Eligibility: FT employees hired prior to March 1, 2023

- If you choose to <u>remain in the plans in which you are currently enrolled</u>, with no changes, you do not need to do anything, and your insurance coverage will continue as it is.
- If you choose to <u>change plan options</u>, are <u>enrolling for the first time</u>, and/or wish to enroll in the FSA for the next year, you must *submit required forms no later than April 7, 2023*.
